Pursuant to NEB. REV. STAT. §32-811(1)(a) and (b) the following contests will not appear on Hitchcock County's 2018 Primary Election ballots:

- **Mid Plains Community College Board of Governors District #1**
- **Middle Republican NRD Board of Directors District #3**
- **Board of Education Hitchcock County, Wauneta Palisade, McCook, Dundy County Stratton, and Hayes Center Public Schools**
- **Hitchcock County Assessor, Attorney, Clerk, Commissioner District #2, Sheriff, Surveyor, and [Treasurer/Democratic only]**

as the number of candidates does not exceed twice the number of vacancies. Candidates for these contests are declared nominated and will appear on the November 6th, 2018 General Election ballot.

NOTICE TO NONPARTISAN VOTERS

A registered voter who is not affiliated with a political party and who desires to vote in the primary election for the offices of:

- **United States Senator**
- **Representative in Congress District #3**

may request a partisan ballot for any one of the three state recognized political parties pursuant to NEB. REV. STAT. §32-912(3). In addition, this year the Nebraska Democratic Party has opened their primary election pursuant to NEB. REV. STAT. §32-912(2) to allow nonpartisan voters to vote in any race where their party is nominating a candidate for a partisan office. No such registered nonpartisan voter shall receive more than one such described partisan ballot.
