VILLAGE BOND ELECTION

Village of Trenton, Nebraska

"Shall the Village of Trenton, Nebraska, issue bonds of said Village in the principal amount not to exceed One Million Two Hundred Fifty Thousand Dollars (\$1,250,000) for the purpose of constructing and equipping a swimming pool and related improvements on land owned by the Village; said bonds to bear interest at rate or rates to be determined by the Chairperson and Village Board of the Village and to become due at such time or times as may be fixed by the Chairperson and Village Board, and"

"Shall the Village of Trenton, Nebraska, cause to be levied and collected annually a special levy of taxes against all the taxable property in the Village sufficient in rate and amount to pay the interest on and principal of said bonds as the same become due?"

Electors voting in favor of said proposition shall blacken the oval opposite the words "FOR said bonds and tax" following said proposition, and electors voting against said proposition shall blacken the oval opposite the words "AGAINST said bonds and tax" following said proposition.

SCHOOL BOND ELECTION

Red Willow County School District 0017

McCook Public Schools

"Shall Red Willow County School District 0017 (McCook Public Schools) in the State of Nebraska (the "District") issue general obligation bonds of the District in an aggregate stated principal amount not to exceed Forty-three Million Five Hundred Thousand Dollars (\$43,500,000), for the purpose of providing funds to pay the costs of demolishing the existing junior high school, making site preparations and constructing, furnishing and equipping a new junior high school facility on the same site, and related improvements along with renovations and improvements to the existing high school and other facilities of the District; such bonds to be issued from time to time, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Education;" and

"Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?"
