A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday the 1st day of October, 2018 commencing at 9:00 o'clock a.m. Present were Vice Chair Ron Wertz, Commissioner Paul Nichols, and County Clerk Margaret Pollmann. Chair Scott McDonald was absent. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown where taken while the convened meeting was open to the attendance of the public. Patron Robert Seybold and Weed Superintendent Bill Hagemann joined the meeting. Discussion held on noxious weed infestations, specifically musk thistle. Mr. Seybold advised as to infested areas and his efforts to control them, specifically those on properties adjoining his. Weed Superintendent Hagemann advised as to unofficial notices sent to land owners. Discussion held on the legal process involved in controlling noxious weeds. Weed Superintendent Hagemann advised as to this process and the difficulties involved relating to land owner cooperation. It was the consensus of the board that once unofficial notices have been sent, and follow up with land owner is attempted, official 10 or 15 day notices shall be sent.

Robert Seybold inquired as to county hiring practices. Board advised that once a county official's budget is approved by the County Board, hiring is done by the elected official. Various aspects of budgets and county operations were discussed.

Attorney D. Eugene Garner joined the meeting.

Highway Superintendent Phillip Dixon advised as to the closeout on Project BRO-7044(27) Trenton Southeast.

Member Nichols moved to direct Vice Chair to execute the Project Construction Conformity Certification and Closeout on Project No. BRO-7044(27) Trenton Southeast. Member Wertz seconded the motion and after consideration, the following members voted in favor of the motion: Wertz and Nichols. McDonald Absent. Motion carried.

Mr. Dixon advised as to various road and bridge projects and discussion was held on the same.

Patron Lyman Hall joined the meeting. Discussion held on Drive 371. Survey will be obtained.

Vice Chair Wertz executed a surplus property affidavit on a 1974 IHC Track Loader and the same was received by the Board.

Treasurer was in receipt of \$1.00 from Vonage America and \$2.00 from Level 3 Communications for 911 surcharges, credited to the 911 Emergency Services Fund; \$23,750.00 from NIRMA for vehicle loss and \$11.13 from Coffeyville Resources and \$75.37 from Central Crude for oil production, both credited to the General Fund and 19,311.53 from the State of Nebraska for Bridge Match Program, credited to the Road Fund.
