A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner’s Room, 229 East D Street, Trenton, Nebraska on Monday, the 1<sup>st</sup> day of April, 2019 commencing at 9:00 o’clock a.m. Present were Chair Paul Nichols, Commissioners Scott McDonald and Ron Wertz and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County’s website [www.hitchcockcounty.ne.gov](http://www.hitchcockcounty.ne.gov). Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. 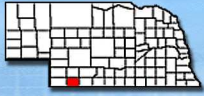

Wilcox for a term of two years commencing June 1, 2019 for the contracted amount of \$36,000 annually. Member McDonald seconded the motion and after consideration, the following members voted in favor of the motion: McDonald, Wertz, and Nichols. Motion carried.

Brian Langenberg and Scott Clifford with Miller and Associates joined the meeting. Mr. Langenberg presented his resignation as appointed County Surveyor effective April 1<sup>st</sup>, 2019 and explained that Scott Clifford, who is a licensed surveyor based in Miller and Associates’ McCook office, was his recommendation as his replacement.

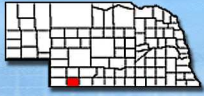
Member Wertz moved to accept the resignation of Brian L. Langenberg as Hitchcock County Surveyor effective April 1, 2019. Member Nichols seconded the motion and after consideration, the following members voted in favor of the motion: Nichols, McDonald, and Wertz. Motion carried.

Member McDonald moved appoint Scott Clifford as Hitchcock County Surveyor effective April 1, 2019 to complete the term ending January 5, 2023 and to direct Chair to execute the Memorandum of Understanding for Appointment of Hitchcock County Surveyor by and between the County and Scott Clifford. Member Wertz seconded the motion and after consideration, the following members voted in favor of the motion. Nichols, Wertz, and McDonald. Motion carried.

Member McDonald moved to adjourn at 10:52 a.m. and to meet for the next regular meeting on Monday, April 15<sup>th</sup>, 2019 at 9:00 a.m. Member Nichols seconded the motion and the roll was called with the following members voting in favor of said motion: Nichols, Wertz, and McDonald. Motion carried.
