A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday, the 5th, day of August, 2019 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Scott McDonald and Ron Wertz, and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website <u>www.hitchcockcounty.ne.gov</u>. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown where taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Nichols called the meeting to order at 9:00 a.m.

County Attorney D. Eugene Garner joined the meeting.

Agenda Item #5, Audit Informal Quotes was taken up. Donald Wilson joined the meeting. One quote was received and opened as published at 10:00 a.m.

Member Wertz moved to enter into a three year agreement for professional audit services with Donald D. Wilson, CPA for County fiscal years ending June 30, 2019, June 30, 2020, and June 30, 2021. Member McDonald seconded the motion and after consideration, the following members voted in favor of the motion: McDonald, Wertz, and Nichols. Motion carried. Mr. Wilson to provide a letter of engagement for consideration at the August 19th, 2019 meeting.

Veteran's Service Committee members Tom Jones, Bob Brown, Richard Baxter and Cliff Johnson and Veteran's Service Officer Robert Scott joined the meeting. A fact sheet was provided regarding number of veteran's visiting the office weekly, implementation of the Mission Act, the need for in home visits, and the

need for interaction with local veteran's associations. VSO Scott advised as to registered and non-registered veteran's within Hitchcock County and those he is serving outside of the County. It was the recommendation of the Veteran's Service Committee to increase VSO office hours to three days per week, those being Tuesday, Wednesday and Thursday beginning September 3rd, 2019. It was the consensus of the Board to approve said request in the 2019-2020 Veteran's Service Officer budget.

Tyson Bardsley with Oak Creek Engineering joined the meeting and provided a recommendation regarding the July 15th, 2019 bids on Structure No. C004402305P on Road 359 located 2 miles south of Palisade.

Member McDonald moved to accept the low bid from Norfolk Contracting in the amount of \$574,934 on structure C004402305P and to direct chair to execute Notice of Award accordingly. Member Wertz seconded the motion and after consideration the following members voted in favor of the motion: Wertz, McDonald and Nichols. Motion carried.

The 2019 Fracture Critical Bridge Inspection Agreement by and between the County and the State of Nebraska, Department of Transportation was reviewed.

Member McDonald offered Signing Resolution #19-11 and moved for its' adoption. Member Nichols seconded the motion and after consideration the roll was called thereupon and the following members voted in favor of the motion: Wertz, McDonald, and Nichols. Said resolution having been consented to by a majority of all members elected to said County Board, was by the Chair declared passed and adopted. Whereas: Nebraska Department of Transportation (NDOT) is developing a transportation project, on the behalf of the county, for which it intends to obtain Federal funds;

Whereas: Hitchcock County as a sub-recipient of Federal-Aid funding is charged with the responsibility of expending said funds in accordance with Federal, State and local laws, rules, regulations, policies and guidelines applicable to the funding of the Federal-aid projects;

Whereas: Hitchcock County and the NDOT wish to enter into a Program Agreement to provide for fracture critical bridge inspection and load re-rating (if necessary) services for the Federal-aid project.
