A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday, the 16th, day of September, 2019 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Scott McDonald and Ron Wertz, and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown where taken while the convened meeting was open to the attendance of the public. 

RESOLUTION #19-16

RESOLUTION SETTING THE PROPERTY TAX REQUEST RESOLUTION NO. 19-16

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Governing Body of the Hitchcock County passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Governing Body of the County of Hitchcock, resolves that:

1. The 2019-2020 property tax request be set at \$1,962,500.00.

2. The total assessed value of property differs from last year's total assessed value by -1%.

3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.240002 per \$100 of assessed value.

4. The County of Hitchcock proposes to adopt a property tax request that will cause its tax rate to be \$.270346 per \$100 of assessed value.

5. Based on the proposed property tax request and changes in other revenue, the total operating budget of County of Hitchcock will be lower than the 2018-2019 budget by 19%

6. A copy of this resolution be certified and forwarded to the County Clerk on or before October 13, 2019.
