



Hitchcock County Board of Commissioners

Trenton, Nebraska May 4th, 2020

A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Community Room, 229 East D Street, Trenton, Nebraska on Monday, the 4th day of May, 2020 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Scott McDonald and Ron Wertz, and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website <u>www.hitchcockcounty.ne.gov</u>. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown where taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Nichols called the meeting to order at 9:00 a.m.

Member McDonald moved to approve the consent agenda consisting of the following items: Approval of the May 4th, 2020 Agenda and approval of the April 20th, 2020 meeting minutes. Member Wertz seconded the motion and after consideration the following members voted in favor of said motion: McDonald, Wertz, and Nichols. Motion carried.

Member Wertz offered Resolution #20-10 and moved for its' adoption. Member McDonald seconded the motion and after consideration the roll was called thereupon and the following members voted in favor of the motion: Nichols, McDonald, and Wertz. Said resolution having been consented to by a majority of all members elected to said County Board, was by the Chair declared passed and adopted. A true, correct and complete copy of said resolution is as follows:

RESOLUTION #20-10

WHEREAS, the County of Hitchcock County, Nebraska, hereinafter referred to as "COUNTY", is a duly organized county, existing pursuant to the laws of the State of Nebraska; and

WHEREAS, it has been ascertained that there are and will be forthcoming inmate medical expenses exceeding the \$18,000.00 budgeted authority within the Hitchcock County Jail's 2019/2020 adopted budget; and

WHEREAS, it appears from the records of the office of the Hitchcock County Clerk, that the Hitchcock County Jail budget function line item 0100-671-00-2-1903 (Medical) within the General Fund does not have sufficient budget authority to meet current expenditures.

NOW, THEREFORE BE IT RESOLVED BY THE COMMISSIONERS OF HITCHCOCK COUNTY, NEBRASKA:

That the Hitchcock County Jail function is hereby authorized to increase its' budget authority by \$28,482.57 and that said authority shall be transferred from the Hitchcock County Sheriff function (line item 0100-651-00-1-0202, Deputy Salary – Other) within the General Fund budget.


Agenda Item #7, Culvert Bids was taken up. Chair Nichols opened the one bid received from Ace Eaton Metals.

RESOLUTION #2020-11

WHEREAS, the County of Hitchcock, State of Nebraska, hereinafter referred to as "COUNTY", is a duly organized political subdivision, existing pursuant to the laws of the State of Nebraska; and

WHEREAS, further in recognition of the fact that the Health Department has suggested precautionary steps to mitigate the spread of the illness, including avoiding crowds, "social distancing" and refraining from physical contact; and

WHEREAS, further in recognition of the fact that many people have chronic medical conditions like diabetes or HIV which make them exceptionally vulnerable to the severe consequence of COVID-19; and

WHEREAS, further in recognition of the fact that all efforts should be utilized to mitigate the exposure and spreading of the illness; and

WHEREAS, on March 31, 2020, Resolution #2020-7 was adopted suspending public access to the Hitchcock County Courthouse is suspended until further notice effective 4:00 P.M. C.T., March 31, 2020, with the County offices remaining staffed to accept phone calls and to schedule appointments as deemed necessary in order to perform their duties and serve the public accordingly; and

WHEREAS, the Board deems it appropriate to now resume *limited* access to the Hitchcock County Courthouse during regular Courthouse hours in order to further provide face-to-face customer service to the citizens of Hitchcock County as necessary.

IT IS THEREFORE RESOLVED BY THE BOARD that public access to the Hitchcock County Courthouse is resumed effective 8:30 A.M. C.T. on May 5, 2020 for regular Courthouse hours, and it is further suggested and encouraged that offices maintain a record documenting all face-to-face contacts specifically and including, name(s), date(s) and time(s) thereof.

IT IS FURTHER RESOLVED that, until further notice, driver's examiner services shall be limited to only Hitchcock County residents at such times as specifically scheduled by the State of Nebraska Department of Motor Vehicles.

IT IS FURTHER RESOLVED that in order to protect the health, safety and wellness of the public and of County employees, that the public is encouraged to conduct business over the phone or electronically in order to limit physical contact to the fullest extent that such services are available.

IT IS FURTHER RESOLVED that the public is encouraged to maintain social distancing and wear masks when interacting with county officials and employees within the Courthouse, and access will be controlled by social distance markings, queue lines, security personal, or staff monitoring in order to reduce the concentration of the number of people in the Courthouse at all times.

IT IS FURTHER RESOLVED that the public is respectfully requested to follow public health guidance and regulations from local health districts, DHMs, and the Centers for Disease Control and Prevention ("CDC") including without limitation: (1) if you have any symptoms of the flu or respiratory illness which includes a sore throat, fever, cough, or shortness of breath; (2) have been diagnosed with or have had close contact with anyone diagnosed with COVID-19; (3) have traveled outside of the health district within the last 14 days; (4) reside or have had close contact with anyone who has traveled outside of the health district in the last 14 days; or (5) have been directed to quarantine, isolate, or self-monitor at home for COVID-19 by any doctor, hospital, or health agency, to not enter the Courthouse, but rather conduct your County business by contacting the appropriate County office by telephone or email.
