



Hitchcock County Board of Commissioners

Trenton, Nebraska April 5, 2021

A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday, the 5<sup>th</sup>, day of April, 2021 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Ron Wertz and Scott McDonald, County Clerk Margaret Pollmann, and County Attorney D. Eugene Garner. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website <a href="www.hitchcockcounty.ne.gov">www.hitchcockcounty.ne.gov</a>. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown where taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Paul Nichols called the meeting to order at 9:00 a.m.

Member Nichols offered Resolution #21-10 and moved for its' adoption. Member Wertz seconded the motion and after consideration the roll was called thereupon and the following members voted in favor of the motion: McDonald, Nichols, and Wertz. Said resolution having been consented to by a majority of all members elected to said County Board, was by the Chair declared passed and adopted. A true, correct and complete copy of said resolution is as follows:

#### **RESOLUTION #21-10**

**WHEREAS**, the Second Amendment to the United States Constitution provides that it is the right of the people to keep and bear arms, and that right shall not be infringed; and





**WHEREAS,** Article I, Section 1-1 of the Nebraska Constitution also provides the right to keep and bear arms, specifically "for security or defense of self, family, home, and others, and for lawful common defense, hunting, recreational use, and all other lawful purposes," and all provides that such right shall not be infringed; and

**WHEREAS,** the United States Supreme Court in the District of Columbia v. Heller, 554 U.S. 570 (2008) affirmed an individual's right to posses firearms, unconnected with service in a militia, for traditionally lawful purposes, such as self-defense within the home; and

**WHEREAS,** it is the desire of the Hitchcock County Board of Commissioners to declare its support of the Second Amendment to the United States Constitution and Article I, Section 1-1 of the Nebraska Constitution; and

**WHEREAS**, the members of the Hitchcock County Board of Commissioners took an oath to support and defend the United States and Nebraska constitutions.

**NOW, THEREFORE, BE IT RESOLVED,** that the Hitchcock County Board of Commissioners hereby declare that we support the rights and liberties of all Hitchcock County citizens guaranteed by the United States and Nebraska Constitutions.

**BE IT FURTHER RESOLVED** that this Board affirms its support for the duly appointed Sheriff of Hitchcock County, Nebraska, and his continuing efforts to uphold the United States and Nebraska Constitutions.

The Board was in receipt of the Resolution/Recommendation of the Hitchcock County Planning Commission on the application for conditional use submitted by SMJ International, LLC.

Chair Nichols opened the public hearing at 10:00 a.m. as published, to hear the applicant and all comments thereon from the public in attendance and to receive evidence regarding the Application for Conditional Use submitted by SMJ International, LLC for a cellular communications monopole tower being 199' high with lightening rod within 100' by 100' lease area to be located beginning at the Northeast corner of the Southwest Quarter (SW½) of Section Twelve (12), Township Two (2) North, Range Thirty-five (35) West of the 6<sup>th</sup> P.M., Hitchcock County, Nebraska on approximately 15 acres owned by the Village of Stratton. Deb Brown for SMJ International, LLC joined the meeting via phone conference. Also present Stratton Village Clerk, Tara Hedrick.





Chair asked for comments from those in favor of granting the conditional use. Tara Hedrick advised the Village of Stratton is in favor of the proposed conditional use. Chair asked for comments from those in opposition of granting the conditional use. There were none. Chair asked for those representing a neutral position. Attorney Garner advised that the Village of Stratton requested that the County consider the application because of a conflict of interest. Chair closed the public hearing at 10:10 a.m.

The Board finds that the requested conditional use of said land is consistent with the Hitchcock County Comprehensive Plan and is permitted as a conditional use in the AG-G General Agricultural District pursuant to Section 501.06 (3) on the following condition

### **RESOLUTION #21-8**

WHEREAS, the Hitchcock County Board of Commissioners having held a public meeting on April 5<sup>th</sup>, 2021, for the purpose of reviewing the Application for Conditional Use submitted by SMJ International, LLC for a cellular communications monopole tower to be located on the NE corner of the SW ½ of Section 12, Township 2 North, Range 35 West, Hitchcock County, Nebraska, and after review and research of said application, to act to approve or disapprove the same; and

**WHEREAS**, the Hitchcock County Board of Commissioners having held a public hearing on April 5<sup>th</sup>, 2021, for the purpose of hearing said application and for hearing comments thereon from the public in attendance and to receive information and documents, in relation thereto; and

**WHEREAS**, the Notice of said Public Hearing was published in the *Hitchcock County News* on March 25, 2021; and

**WHEREAS,** a copy of the notice of said Public Hearing was duly mailed on March 4<sup>th</sup>, 2021 by U.S. Mail, proper first class postage prepaid, to all adjacent landowners as evidenced by the Certificate of Service on file in the office of the Hitchcock County Clerk; and

**WHEREAS**, the Hitchcock County Board of Commissioners have received the recommendation of the Hitchcock County Planning Commission recommending approval of said application; and

WHEREAS the Hitchcock County Board of Commissioners, having found that the requested conditional use of said land is consistent with the Hitchcock County Comprehensive Plan and is permitted as a conditional use in the AG-G General Agricultural District pursuant to Section 501.06 (3) on the following conditions to wit:

### CONDITION(S):

1. Said tower shall comply with any applicable airport hazard height limitations and shall be setback from the right-of-way of any public roadway, from the nearest property line of any undeveloped lot of record of less than 20 acres in area or any public use area and from the nearest wall of any neighboring church, school, or residential dwelling unit by a distance equal to or exceeding the height of said tower;





- 2. The applicant shall exercise and take all reasonable necessary steps to insure that there is no interference for adjoining residential landowners and to correct any interference if it occurs;
- 3. Refer to *Memorandum* dated February 24, 2021, submitted by Darin Morgan, Hitchcock County Zoning Administrator, attached hereto as "Exhibit A" and incorporated herein by this reference; and
- 4. Letter from legal counsel for Village of Stratton representing/certifying that the proposed use is permitted by the applicable Village zoning ordinance(s)/zoning regulations(s), and/or that the Village of Stratton does not exercise jurisdiction over the area of the proposed site.

**NOW, THEREFORE, BE IT RESOLVED** that the Conditional Use Application of SMJ International, LLC for a cellular communications monopole tower to be located on the NE corner of the SW ¼ of Section 12, Township 2 North, Range 35 West, Hitchcock County, Nebraska, on the conditions and exceptions, if any, set forth hereinbefore be approved.

### **RESOLUTION 21-9**

WHEREAS, NEB. REV. STAT. §76-2,112 requires that each conservation or preservation easement shall be approved by the appropriate governing body. Such approving body shall first refer the proposed acquisition to and receive comments from the local planning commission with jurisdiction over such property; and

**WHEREAS,** Clint R. Schafer and Kayla M. Schafer, husband and wife (Grantors), have applied to the Middle Republican Natural Resources District (Grantee) for a Conservation Easement (71 certified irrigated acres only) for the real estate legally described as the West Half (W ½) of the Southwest Quarter (SW ¼) of Section Twenty-nine (29), Township Four (4) North, Range Thirty-two (32) West of the 6<sup>th</sup> P.M., Hitchcock





County, Nebraska, except that part deeded to the State of Nebraska in Deed Book 39, Page 318, recorded November 1, 1939; and

**WHEREAS**, the Hitchcock County Board of Commissioners referred said proposed acquisition to the Hitchcock County Planning Commission on March 15, 2021; and

**WHEREAS**, the Hitchcock County Board of Commissioners is in receipt of the following finding from the Hitchcock County Planning Commission:

The Hitchcock County Planning Commission finds that the proposed conservation easement relating to the sale of (71 certified irrigated acres water only) by and between Clint R. and Kayla M. Schafer, husband and wife (Grantors) and the Middle Republican Natural Resources District (Grantee) from a well on the W ½ of the SW ¼ of Section 29, Township 4 North, Range 32 West of the 6<sup>th</sup> P.M. in Hitchcock County, Nebraska conforms with Hitchcock County's Comprehensive Zoning Plan.

**WHEREAS**, the Board finds that the proposed conservation easement conforms with Hitchcock County's Comprehensive Zoning Plan.

NOW, THEREFORE BE IT RESOLVED that the Hitchcock County Board of Commissioners approve the application for a conservation easement by and between Clint R. Schafer and Kayla M. Schafer, husband and wife (Grantors) and the Middle Republican Natural Resources District on (71 certified irrigated acres water only) from a well on the real estate legally described as the West Half (W ½) of the Southwest Quarter (SW ¼) of Section Twenty-nine (29), Township Four (4) North, Range Thirty-two (32) West of the 6<sup>th</sup> P.M., Hitchcock County, Nebraska, except that part deeded to the State of Nebraska in Deed Book 39, Page 318, recorded November 1, 1939.

**WHEREAS**, the Hitchcock County Board of Commissioners desires to provide maximum protection to the users of roads in Hitchcock County; and

WHEREAS, said Board of Commissioners acknowledges the State of Nebraska has adopted the Manual on Uniform Traffic Control Devices (MUTCD) as published by the Federal highway Administration; and

WHEREAS, in accordance with the Manual of Local Control Devises which states, local authorities in their respective jurisdiction shall place and maintain the traffic control devices on roads under their jurisdiction as they deem necessary to indicate and to carry out local traffic ordinances or to regulate, warn or guide traffic. All traffic control devices erected shall conform to the manual and specifications; and

WHEREAS, official recognition of the proper position of regulatory types of signs is required to provide legal enforcement.

WHEREAS, in the interest of public safety, the board is considering reducing the speed limit on the North ½ mile of Road 376 between Sections Twenty-six (26) and Twenty-seven (27), Township Four (4), Range Thirty-one (31) and Road 722 between Sections Twenty-three (23) and Twenty-six (26), Township Four (4), Range Thirty-one (31) West of the 6<sup>th</sup> P.M. in Hitchcock County, Nebraska and for the permanent placement of regulatory speed limit signs on said roads accordingly.

**NOW THEREFORE, BE IT RESOLVED** that the County Highway Superintendent, is hereby directed to perform a traffic study on North ½ miles of Road 376 between Sections Twenty-six (26) and Twenty-seven (27), Township Four (4), Range Thirty-one (31) and Road 722 between Sections Twenty-three (23) and Twenty-six (26), Township Four (4), Range Thirty-one (31), West of the 6<sup>th</sup> P.M. in Hitchcock County, Nebraska and to submit in writing to the county board, a traffic study report relating to permanent placement of regulatory signs on said road establishing speed limit of not more than 35 MPH.
