Hitchcock County Board of Commissioners

Trenton, Nebraska July 17, 2023

A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday, the 17th day of July 2023 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols and Commissioners Ron Wertz and Scott McDonald and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication in the Hitchcock County News, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown where taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Nichols called the meeting to order at 9:00 a.m.

Member Nichols moved to approve the consent agenda consisting of the following items: Approval of the July 3rd, 2023 meeting minutes; Approval of the July 17th, 2023 agenda. Member McDonald seconded the motion and after consideration, the following members voted in favor of the motion: McDonald, Wertz and Nichols. Motion carried.

Scott McDonald advised that he has had complaints regarding the County mowing weeds and that NEB. REV. STAT. §39-1811 provides in part that it shall be the duty of the landowners to mow all weeds that can be mowed with the ordinary farm mower to the middle of all public roads and drainage ditches running along their lands at least twice each year, namely, before July 15th, for the first time and sometime in August for the second time.

Member Nichols moved to approve the Application To Occupy Hitchcock County Road Right of Way filed by Great Plains for underground fiberoptic in Section 15, Township 3, Range 32 Hitchcock County, Nebraska. Member Wertz seconded the motion and after consideration, the following members voted in favor of the motion: Wertz, McDonald and Nichols. Motion carried.

Dawna Vap and Korky Vernon met with the Board advised as to a recent meeting with Senator Fisher, Senator Pete Ricketts, and Congressman Adrian Smith in Washington, DC regarding the Bureau of Reclamation land transfer issue.

County Attorney D. Eugene Garner joined the meeting.

Kiley Joyce and Mary Lawson with Region II Services Developmental Disabilities gave an overview of the agency's services.

Member Nichols offered Resolution #23-10 and moved for its' adoption. Member McDonald seconded the motion and after consideration the roll was called thereupon and the following members voted in favor of the motion: Nichols, Wertz, and McDonald. Said resolution having been consented to by a majority of all members elected to said County Board, was by the Chair declared passed and adopted. RESOLUTION 23-10

WHEREAS, the Hitchcock County Board of Commissioners have identified the opportunity for the expansion of access to broadband internet for residents of rural Hitchcock County through various programs administered by the United States Department of Agriculture.

WHEREAS, the Hitchcock County Board of Commissioners believe that access to high speed broadband internet in a modern, information drive age, is an important to residents of Hitchcock County as the electrification of rural homes and farms was in the 1930's and 1940's.

WHEREAS, the Hitchcock County Board of Commissioners believe that the first step toward connecting rural Hitchcock County residents with broadband internet access is the identification and formulation of plan to fairly distribute and implement such broadband access to areas with limited or no current broadband access.

WHEREAS, the United States Department of Agriculture, through the Infrastructure Investment and Jobs Act, offers technical assistance grants which are designed to assist political subdivisions, such as Hitchcock County, with identifying areas of inadequate broadband service and formulate plans for how to extend service to those areas.

WHEREAS, Hitchcock County has a long standing relationship with West Central Nebraska Development District, which in turn has partnered with the South East Nebraska Development District to pool resources and expertise in the application for technical assistance grants from the United States Department of Agriculture and the distribution and administration of grant funds received.

WEREAS, the Hitchcock County Board of Commissioners believe that the South East Nebraska Development District, in cooperation with the West Central Nebraska Development District, are well suited to represent the interest of Hitchcock County and its residents in the application and administration of technical assistance grants from the United States Department of Agriculture and thus to begin the important process of bringing high speed broadband internet access to the areas of Hitchcock County that are now underserved or without any broadband access.

THEREFORE BE IT RESOLVED by the Hitchcock County Board of Commissioners, due to the generationally transformative change that access to broadband internet represents for many rural Hitchcock County residents, the County of Hitchcock, Nebraska, fully and formally supports the application of the South East Nebraska Development District to receive a technical assistance grant from the United States Department of Agriculture in order to conduct comprehensive broadband planning, feasibility studies, and project development initiatives.
