Hitchcock County Board of Commissioners

A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Tuesday the 21st day of January 2025 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Ron Wertz and Christopher Baker and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication on January 16th, 2025 in *Scoop Media News*, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Nichols called the meeting to order at 9:00 a.m.

The floor was opened for nominations for Chair for calendar year 2025. Member Ron Wertz nominated Paul Nichols. The nomination was seconded by Baker. There were no further nominations and nominations ceased. The roll was called on the nomination of Paul Nichols for Chair for calendar year 2025 and the following members voted in favor of said nomination: Wertz and Baker. Member Nichols abstained. Motion carried and Paul Nichols was declared Chair for 2025.

The floor was opened for nominations for Vice Chair for calendar year 2025. Member Nichols nominated Ron Wertz. The nomination was seconded by Baker. There were no further nominations and nominations ceased. The roll was called on the nomination of Ron Wertz for Vice Chair for calendar year 2025 and the following members voted in favor of said nomination: Nichols and Baker. Member Wertz abstained. Motion carried and Ron Wertz was declared Vice Chair for 2025.
