A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Monday the 16th day of June 2025 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Christopher Baker and Ron Wertz and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication on June 12th, 2025 in *Scoop Media News*, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Nichols called the meeting to order at 9:00 a.m.

Chair Nichols advised as to updates on Bureau of Reclamation Land Transfers.

Member Baker moved to direct Chair to execute the Agreement For the Contribution of Funds No. 25AG630088 Between The Bureau of Reclamation, Missouri Basin Region, Nebraska-Kansas Area Office and Hitchcock County and Frontier County for Swanson and Hugh Butler Concession and Cabins Title Transfer, Pick-Sloan Missouri Basin Program, Frenchman Cambridge Division, Nebraska. Member Nichols seconded the motion and after consideration the following members voted in favor of the motion: Nichols, Baker, and Wertz. Motion carried.

Member Wertz moved to appoint Darcie Johnson to the Southwest Nebraska Public Health Department Board of Directors. Member Nichols seconded the motion and after consideration, the following members voted in favor of the motion: Wertz, Nichols, and Baker. Motion carried.

Member Wertz moved to direct Chair to execute the engagement agreement for 2025/2026 budget preparation services by and between Daniel D. Miller, CPA and the County in the amount of \$3,350.00 and further to direct Chair to execute the required Nebraska State Auditor "Responsibility" form. Member Baker seconded the motion and after consideration the following members voted in favor of the motion: Baker, Nichols, and Wertz. Motion carried.

Member Baker moved to direct Chair to execute the Affidavit of Surplus property relating to a 1983 Ford Conventional Cab truck. Member Wertz seconded the motion and after consideration the following members voted in favor of the motion: Nichols, Wertz, and Baker. Motion carried.

RESOLUTION 25-12

A RESOLUTION Approving the Transfer of Land from the Bureau of Reclamation to Hitchcock and Frontier Counties, and Approving the Equitable Division of Administrative Fees

WHEREAS:

- The Bureau of Reclamation holds title to certain federal land located within the jurisdictions of Hitchcock and Frontier Counties; and
- These lands have been deemed surplus to federal needs and are eligible for transfer to local governments under applicable federal laws and regulations; and
- Hitchcock and Frontier Counties have jointly expressed interest in acquiring portions of the land to support local infrastructure, development, and public use; and
- The total administrative cost associate with the land transfer is \$111,200 as determined by the Bureau of Reclamation.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODIES OF HITCHCOCK AND FRONTIER COUNTIES THAT:

1. **The transfer of land** from the Bureau of Reclamation to Hitchcock and Frontier Counties is hereby approved, subject to all federal regulations and procedural requirements;

- 2. **The administrative fee of \$111,200** shall be split **equally** between Hitchcock County and Frontier County, with each county responsible for \$55,600;
- 3. Each county shall coordinate with the Bureau of Reclamation and any other relevant agencies to finalize the documentation, surveys, and procedural steps necessary to complete the land transfer;
- 4. This resolution shall become effective upon adoption by both county governing bodies.

Zoning Administrator Mike Erickson joined the meeting and discussion was held on updating the County's Comprehensive Plan.

Chair Nichols recessed the regular meeting at 10:00 a.m. and opened the public hearing for the purpose to hear the applicant and all comments thereon from the public in attendance and to receive evidence regarding the Application for Conditional Use submitted by Brandon Flannery on behalf of MB Club, LLC for a data center on part of the SE½ of Section 4, Township 1 North Range 33 West, Hitchcock County, Nebraska. Chair noted posting of Open Meetings Act to those present.

Charlee Hrnchir, Bill Roddy, Brandon Flannery and Assessor Terra Riggs joined the meeting.

The Resolution/Recommendation of the Hitchcock County Planning Commission relating to the Application for Conditional Use submitted by Brandon Flannery on behalf of MB Club, LLC was received and acknowledged.

Applicant Brandon Flannery presented the Application for Conditional Use and responded to questions posed by the board and those present.

Chair Nichols asked if there were any comments from the opponents of the application. Charlee Hrnchir advised that her residence is within one mile of the subject facility and voiced decibel level concerns. Mrs. Hrnchir advised that she had not been contacted by the applicant(s) with regards to an impact easement and her present stance is that she will not grant or execute an impact easement. Exhibit "D" Knots to MPH Wind Speed Conversion was received by the Board.

Chair Nichols asked if there were any comments from proponents of the application. There were none.

Chair inquired if there were any comments from a neutral position. Hitchcock County Assessor Terra Riggs advised as to value of real estate and personal property of the subject conditional use.

Chair inquired if there were any further comments. Paul Nichols commented on procedural and communication frustrations through the conditional use process.

Zoning Administrator Mike Erickson presented his staff report relating to conditional use application #2-2025. Mr. Erickson advised as to conditions, those being the requirement of an impact easement with the owner of a residence within one mile of the data center location and the required filing by the applicant of a zoning permit.

Chair closed the public hearing at 10:37 a.m. a.m. this date and the public meeting that was previously recessed was re-opened.

Chair inquired if any board member(s) had a conflict of interest regarding the application being considered. There were none.

Motion Wertz by to table action on the application for conditional filed by Brandon Flannery on behalf of MB Club LLC for a data center on part of the SE ½ of Section of Section 4, Township 1 North, Range 33 West, Hitchcock County, Nebraska, until such time as an impact easement(s) with surrounding residence(s) within a mile of the data center location is/are obtained. Member Baker seconded the motion and after consideration the following members voted in favor of the motion: Wertz, Baker and Nichols. Motion carried.
