A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Tuesday the 2<sup>nd</sup> day of September 2025 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioners Christopher Baker and Ron Wertz and County Clerk Margaret Pollmann. Notice of the meeting was given in advance thereof by publication on August 28<sup>th</sup>, 2025 in *Scoop Media News*, the designated method for giving notice. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held.

Chair Nichols called the meeting to order at 9:00 a.m.

Chair Nichols opened the public hearing relating to the application to the Nebraska Department of Economic Development for a Community Development Block Grant (CDBG) at 10:31 a.m. as published. The purpose of said grant is for updating the County's Comprehensive Plan and Zoning Regulations. Taylor Provost, Economic Development Specialist with West Central Nebraska Development District advised as to the purpose of said grant. Zoning Administrator Mike Erickson and Planning Commission Chair Dustin Ladenburger were also present.

Chair asked for those in favor of the applying for said grant. Dustin Ladenburger spoke in favor of the grant and advised that the updates are definitely due. Ms. Provost advised as to the grant process.

Chair asked for those against applying for said grant. There were none.

Chair asked for comments from a neutral position. There were none.

Chair Nichols closed the public hearing at 10:36 a.m.

Member Baker moved to retain West Central Nebraska Development District to prepare and submit an application for a Community Development Block Grant (CDBG) - Planning Grant and to direct chair to execute necessary documents relating to the same. Member Nichols seconded the motion and after discussion a roll call vote was had. Nichols, Yes; Wertz, Yes; Baker, Yes. Motion carried.

## RESOLUTION 25-15 RESOLUTION AUTHORIZING CHIEF ELECTED OFFICIAL TO SIGN AN APPLICATION FOR CDBG FUNDS

Whereas, the County of Hitchcock, Nebraska, is an eligible unit of a general local government authorized to file an application under the Housing and Community Development Act of 1974 as amended for Small Cities Community Development Block Grant Program, and,

Whereas, the County of Hitchcock, Nebraska, has obtained its citizens' comments on community development and housing needs; and has conducted public hearing(s) upon the proposed application and received favorable public comment respecting the application which for an amount of 23,000 for Hitchcock County is requesting CDBG funds for a project to update the County's Comprehensive Plan and Zoning Regulations. The need for this project was identified through recognition that the County's current planning documents are outdated and no longer adequately address contemporary land use challenges, economic development opportunities, and regulatory compliance requirements. The proposed planning activities will take place countywide throughout Hitchcock County, with particular focus on unincorporated areas and coordination with incorporated municipalities within the County boundaries.; and,

NOW, THEREFORE, BE IT RESOLVED BY

Board of County Commissioners of Hitchcock County, Nebraska, that the Board Chairman be authorized and directed to proceed with the formulation of any and all contracts, documents or other memoranda between Hitchcock County, Nebraska and the Nebraska Department of Economic Development so as to effect acceptance of the grant application.
