Highway Superintendent Lance Harter met with the board via phone conference regarding Structures C004404510 and C004413405.

Member Wertz moved to direct Chair to execute the Agreement for Professional Services by and between Oak Creek Engineering and the County relating to structure C004413405. Treasurer Jackie Drain provided a copy of the Semi Annual Statement for December 31, 2025. Treasurer Drain also presented the pledged security reports for November and December 2025.
