

Hitchcock County Board of Commissioners

A meeting of the County Board of Commissioners of Hitchcock County, Nebraska was held at the Hitchcock County Courthouse Commissioner's Room, 229 East D Street, Trenton, Nebraska on Tuesday the 17th day of February 2026 commencing at 9:00 o'clock a.m. Present were Chair Paul Nichols, Commissioner Christopher Baker and County Clerk Margaret Pollmann. Commissioner Ron Wertz was absent. Notice of the meeting was given in advance thereof by publication on February 12th, 2026 in *Scoop Media News*, the designated method for giving notice. Board agendas are posted on the County's website www.hitchcockcounty.ne.gov. Notice of the meeting was given to the Chair and all members of the Board. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public. The Open Meetings Act was available for review and Chair indicated the location of such copy in the room where the meeting was being held. Bill Roddy and Jason Gohl were also present.

Chair Nichols called the meeting to order at 9:00 a.m.

Member Nichols moved to approve the consent agenda consisting of approval of the February 17th, 2026 agenda and approval of the February 2nd, 2026 meeting minutes. Member Baker seconded the motion and after consideration a roll call vote was had as follows: Nichols, Yes; Baker, Yes; Wertz, Absent. Motion carried.

Member Nichols offered Resolution #26-9 and moved for its' adoption. Member Baker seconded the motion and after consideration the roll was called thereupon as follows: Baker, Yes; Wertz, Absent; Nichols, Yes. Said resolution having been consented to by a majority of all members elected to said County Board, was by the Chair declared passed and adopted. RESOLUTION NO. 26-9

WHEREAS the County of Hitchcock, Nebraska, is a political subdivision of the State of Nebraska; and

WHEREAS, on September 15th, 2025, the County adopted the 2025/2026 Hitchcock County Budget; and

WHEREAS, the County Board budgeted the expenditure of inheritance tax funds during the 2025/2026 fiscal year as follows: \$705,665.00 to the General Fund and \$400,000.00 to the Road Fund to reduce the property tax request to be transferred as necessary to meet current expenditures.

THEREFORE BE IT RESOLVED that the County Treasurer is hereby authorized and directed to immediately transfer the sum of \$5,411.00 from the Inheritance Tax Fund to the Swanson Land Fund for the purpose of meeting current expenditures.

Sheriff Ryan King joined the meeting. Discussion held on the Interlocal Agreement between Red Willow County and Hitchcock County for housing inmates. The Sheriff's office January 2026 monthly report was received. Attorney D. Eugene Garner joined the meeting and advised as to the proposed interlocal agreement.

Motion by Baker to direct Chair to execute the Interlocal Agreement between the County of Red Willow, Nebraska and the County of Hitchcock County, Nebraska for housing inmates at the Red Willow County Corrections Center (Detention Facility). Member Nichols seconded the motion and after consideration a roll call vote was had as follows: Nichols, Yes; Baker, Yes; Wertz, Absent.

Sheriff King advised as to a catastrophic inmate medical insurance proposal. Sheriff King will procure an updated proposal and this item will be placed on the March 2nd, 2026 agenda.

Discussion held on cellular internet backup providers. It was the consensus of the board to obtain additional quotes for this service.

Attorney Garner advised there was nothing new to report from West Central Nebraska Development District regarding planning and zoning updates. Attorney Garner also advised as to CI 25-1 Koetter vs. Rippen.

Chair Nichols advised as to conversations with FEMA, Highway Superintendent Lance Harter and Deputy Director Joanna Lemoine with Region 51 Emergency Management regarding the Valley Drive project.

Highway Superintendent Lance Harter joined the meeting via phone conference regarding replacement of Structure No. C004413405 (west of the Stone Church). It was the consensus of the Board to proceed with the project and begin the process of soliciting bids.

Member Baker moved to adjourn at 10:42 a.m. and to meet for the next regular meeting on Monday, March 2nd, 2026 at 9:00 a.m. Member Nichols seconded the motion a roll vote was had as follows: Wertz, Absent; Nichols, Yes; Baker, Yes. Motion carried.
